Administrative Measures on the Restriction of the Use of Certain Hazardous Substances in Electrical and Electronic Products

(Consultation Draft)

Chapter 1 General Principles

Article 1 In order to control and reduce the environmental pollution caused by discarded or waste electrical and electronic products (EEPs), promote the production, sale and importation of low-pollution EEPs and integrated use of resources, and protect the environment and human health, the Measures is hereby promulgated in accordance with the Law of People's Republic of China on Promotion of Clean Production, Law of the People's Republic of China on the Prevention and Control of Environmental Pollution by Solid Waste, Regulation on the Administration of the Recovery and Disposal of Waste Electrical and Electronic Products and other relevant laws and regulations.

Article 2 The Measures applies to all EEPs manufactured, sold and imported in the territory of the People's Republic of China.

Article 3 The definitions of the terms under the Measures are as follows:

- Electrical and electronic products (EEPs) refer to devices and accessories with a nominal working voltage under 1500 V DC, or 1000 V AC. Equipment for power generation, transmission and distribution are excluded.
- (2) Pollution caused by EEPs refers to the destruction, damage, waste or other adverse effects to the environment, resources, and safety of human life, health and property, which are caused by EEPs containing hazardous substance exceeding the limits specified in relevant national or industrial standards.
