RESOLUTION

REDUCTION, DECENTRALIZATION, AND SIMPLIFICATION OF ADMINISTRATIVE PROCEDURES AND BUSINESS CONDITIONS WITHIN THE SCOPE OF THE MINISTRY OF INDUSTRY AND TRADE

Pursuant to Law on Government Organization No. 63/2025/QH15;

*Pursuant to Law on Promulgation of Legislative Documents No. 64/2025/QH15, amended and supplemented
by Law No. 87/2025/QH15;*

At the request of Minister of Industry and Trade;

*The Government of Vietnam hereby promulgates the Resolution on reduction, decentralization, and
simplification of administrative procedures and business conditions within the scope of the Ministry of
Industry and Trade.*

Chapter I

GENERAL PROVISIONS

Article 1. Scope

This Resolution prescribes the reduction, decentralization, and simplification of administrative procedures and business conditions within the scope of the Ministry of Industry and Trade.

Article 2. Principles for reduction, decentralization, and simplification of administrative procedures and business conditions

1. The reduction, decentralization, and simplification of administrative procedures and business conditions must ensure the creation of favorable conditions for organizations and individuals; foster a favorable, healthy, and fair business environment; promote innovation and creativity; and enhance the effectiveness and efficiency of state management.
2. Continue to comprehensively reform and improve the effectiveness of the single-window and interconnected single-window mechanisms; ensure publicity and transparency; optimize procedures; implement administrative procedures to be initiated regardless of administrative boundaries; boost labor productivity, strengthen effectiveness and efficiency of management; and bring about robust improvements in administrative governance.
3. Continue to replace or reduce the required dossier components in administrative procedures based on the level of accessibility and utilization of databases; do not do not request dossier components for administrative procedures if the information therein is available in databases disclosed by the database governing bodies.

Chapter II

REDUCTION, DECENTRALIZATION, AND SIMPLIFICATION OF ADMINISTRATIVE PROCEDURES AND BUSINESS CONDITIONS WITHIN THE SCOPE OF THE MINISTRY OF INDUSTRY AND TRADE

Article 3. Decentralization of administrative procedures within the scope of the Ministry of Industry and Trade

The decentralization of administrative procedures within the scope of the Ministry of Industry and Trade shall be implemented in Appendix I issued together with this Resolution.

Article 4. Reduction of business conditions within the scope of the Ministry of Industry and Trade

The reduction of business conditions within the scope of the Ministry of Industry and Trade shall be implemented in Appendix II issued together with this Resolution.

Article 5. Reduction and simplification of administrative procedures within the scope of the Ministry of Industry and Trade

The reduction and simplification of administrative procedures within the scope of the Ministry of Industry and Trade shall be implemented in Appendix III attached to this Resolution.

Chapter III

IMPLEMENTATION PROVISIONS

Article Implementation

1. Ministry of Industry and Trade shall

a) Be held accountable for implementing, monitoring, urging, and inspecting the implementation of this Resolution;

b) Submit to competent authorities for promulgation, or promulgate within its authority, legal documents according to the Appendix issued together with this Resolution to decentralize, reduce, and simplify administrative procedures and business conditions, ensuring they take effect before March 1, 2027.

2. Ministries, ministerial-level authorities, other agencies and organizations shall, within the scope of their assigned functions and powers, take charge of or coordinate in the implementation of this Resolution.

3. Provincial People's Committees shall:

a) Organize the implementation of tasks and powers decentralized under this Resolution and relevant laws on local government organization;

b) Mobilize and arrange local resources for implementation.

Article 7. Transitional provisions

1. For dossiers requesting the settlement of administrative procedures in the fields specified in the Appendix issued together with this Resolution that have been received by competent authorities or bear a postal postmark before the effective date of this Resolution, the legal regulations in effect at the time of dossier receipt shall apply.
