### Cosmetic Products

Definition: Cosmetics in China refer to daily chemical industrial products applied to skin, hair, nails, lips and other surfaces of human body by scrubbing, spraying or other similar methods for the purpose of cleansing, protecting, beautifying and modifying.

Overseas cosmetic companies shall authorize a local enterprise based in Mainland China as the Responsible Person (RP) for cosmetics registration and notification.

### Toothpaste

The toothpaste is not defined as cosmetics but managed as general cosmetics in China, which needs to follow notification procedures. The toothpaste can claim anti-caries, inhibiting plaque, anti-dentine hypersensitivity, gum problem alleviation, etc.

### Soap

The soap is not managed by Cosmetic Supervision and Administration Regulations (CSAR), but those with special cosmetic efficacy claims are managed as special cosmetics and need to follow registration procedures.

# General Cosmetics can avoid animal testing by providing cosmetic safety risk assessments if the product meets the following conditions:

- Cosmetic manufacturers have obtained GMP certification issued by the competent government department of the country (region) where it is located.
- Products claim not to be used by infants or children.
- Products do not use new cosmetic ingredients that are still under safety monitoring.
- According to the results of quantitative grading, the notifier, domestic RP and production enterprise are not listed as key regulatory objects.

# O New Cosmetic Ingredient (NCI)

Inventory of Existing Cosmetic Ingredients in China (IECIC)

All the ingredients allowed to be used in cosmetic products in China are listed in IECIC. The unlisted ingredients are defined as new cosmetic ingredients (NCIs) which shall undergo registration or notification procedures before being utilized in cosmetics.

Existing or listed cosmetic ingredients that adjust the purpose of use, safe usage, etc. shall be subject to NCI registration or notification as well.

Overseas NCI companies shall authorize a local enterprise based in Mainland China as the Responsible Person (RP) for NCI registration and notification.




