The Catalogue of Feed Additives (2013) was issued by the Ministry of Agriculture (MOA) of the People's Republic of China on December 30, 2013 in Announcement No.2045, and came into effect on February 1,2014. It was later revised several times by the Ministry of Agriculture and Rural Affairs (MARA).

According to the Announcement No.2045 of the MOA and the subsequent revised announcements, the Catalogue of Feed Additives is compiled and summarized as follows, and will be updated in a timely manner according to the approval and revision status for reference by all parties.
